



Clenergy RUNNUR® Cable Management Product Warranty

Definitions

In this warranty, the following terms have the meanings given below:

"Clenergy"	(i) Clenergy Technology Co., Ltd or (ii) Clenergy Australia (iii) Clenergy International (HK) Limited or (iiii) Clenergy (Tianjin) Co., Ltd.
"Commencement Date"	the day of the delivery of the Products to the Customer.
"Customer"	the person or firm who purchases the Products from Clenergy.
"Product"	Clenergy RUNNUR® Cable Management Product purchased by the customer from Clenergy.

Warranty Scope

In accordance with the categories set out in the table below, Clenergy warrants to the Customer that each Product Type at the original installation site shall be free of failure caused by defects in materials and workmanship under the relevant Application for the relevant Warranty Period subject to categories of corrosive environment classified by the International Standard ISO 9223:2012.

Warranty Remedies

During the applicable Warranty Period, if any Product is found to be defective, the Customer must notify Clenergy in writing. Clenergy will at its election either:

- *Repair the defective Product; or*
- *Resupply the defective Product or a product of an equivalent function.*

Provided that the Product has been maintained correctly in accordance with section "Product Care" below. The cost of dismantling the defective component or any other indirect loss is excluded from this warranty. This warranty is not transferrable, not assignable and is VOID when the Product is transferred to another party without the prior written consent of Clenergy.

The foregoing warranty is exclusive and in lieu of all other warranties whether written, oral or implied. To the maximum extent permitted by law, any implied warranties of merchantability or fitness for a particular purpose are specifically excluded.

Product Care

Your Product is designed to be durable with minimal care, however it is important that you maintain your Product with care, including as follows:

- MAC Product can be stored outside, but should be loosely stacked, elevated off the ground, and placed in a well-ventilated dry location. If appearance is important, MAC product should be stored indoors to prevent water or other foreign materials staining.
- The bolted connections at joints should be checked regularly (recommended as part of a facility's routine maintenance schedule for electrical cables) and tightened at all appropriate areas;
- Regular inspections should be made to remove deposits of dust, foreign objects and debris to improve ventilation and reduce the potential for fire hazard. These inspections should occur after severe weather, especially for outdoor installation.

Warranty Exclusions

- This Warranty does not cover material finish, or other considerations that do not substantially affect structural performance.
- Any natural impairment and corrosion that does not compromise the structural performance.
- The visual aspect of the cut edges and discoloration of the Product surface due to run-off from cut edges or any adjacent part (made of any material).
